- Original DS-2019 (J visa) **or** copy of I-20 (F or M visa)
- SEVIS payment receipt (SEVIS fee can be paid here: [www.fmjfee.com](http://www.fmjfee.com))
- DS-160 Application Confirmation Page
- DHL payment receipt

## PASSPORT RETURN

We offer two options to return your passport:

1. Premium Delivery with DHL
2. Personal pick-up; once the status of your visa applications shows **Issued** on this tracking web-site: [ceac.state.gov/CEACStatTracker/Status.aspx](http://ceac.state.gov/CEACStatTracker/Status.aspx), you may pick it up during the below collection times (closed on Norwegian and American public holidays);
  - Wednesdays between 14:30-15:00
  - Fridays between 11:00-11:30

## VISITING THE EMBASSY

- Do not bring bags or purses larger than 17x16x32 cm. Large bags are not permitted inside the Embassy, and they cannot be stored at the security checkpoint.
- No electronic devices are permitted inside the Embassy.
- Do not come to the Embassy more than 10 minutes ahead of your appointment.
- The line for security screening forms outdoors, and you may need to wait outside for 20 minutes or more. Be aware of weather conditions and dress accordingly.
- Be prepared to spend at least 2 hours at the Embassy when attending your visa appointment.
- Late arrival and/or failure to bring all required items may result in having to book a new appointment.
